ARTICLES OF INCORPORATION SECRETARY OF STATE

OF

ANGEL'S HALL, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: ANGEL'S HALL, INC.

ARTICLE II - PURPOSE

The corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.
