

# ARTICLES OF INCORPORATION OF SECRETARY ON CALL, INC.



The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. CORPORATE NAME

The name of this corporation is: Secretary On Call, Inc.

# ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

## ARTICLE III. DURATION
