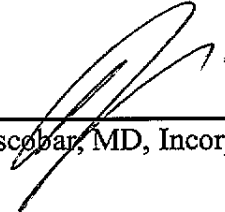

THIRD. The purpose for which the corporation is organized is to render the professional service of Medicine.

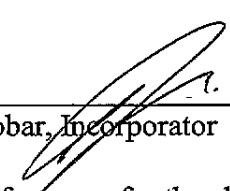
FOURTH. The total number of shares which the corporation shall have the authority to issue is 1,000 shares of Common Stock, and the par value of each of such shares is \$1.00.
