The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Brad Hall, D.M.D., P.A.

ARTICLE II. CORPORATE ADDRESSES

The principal office and mailing address of the corporation is 12276 San Jose Boulevard, Unit 101, Jacksonville, FL 32223 at the time of execution of these Articles.

ARTICLE III. PURPOSE

This corporation is organized as a Professional Association under and pursuant to the provisions of Chapter 607 and Chapter 621, Florida Statutes, for the purpose of transacting any or all lawful business for which such a corporation may be incorporated under said chapters and for the purpose of rendering dental services through those officers and employees of the corporation duly authorized by law to provide the same.

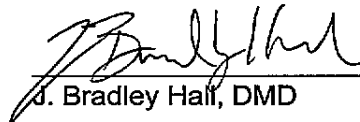
