The undersigned subscribers to these articles of incorporation, each a natural person competent to contract hereby associate themselves together to form a Corporation under the laws of the State of Florida.

SECTION 1.01 NAME: The name of this Corporation is:

SECTION 9.00 NATURE OF BUSINESS.

SECTION 9.01 To engage in every aspect and phase of the business of any and all business which is not contrary to the laws of the United States of America and of the State of Florida.

SECTION 9.02 To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, deal in and with, goods, wares, merchandise, real and personal property and services, of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety, railroad, canal, telegraph, telephone or cementery company, a building and loan association, mutual fire insurance association, fraternal benefit society, state fair or exposition.

SECTION 9.03 To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capita! stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida or any other states of goverments, and while owner of such stock to exercise all the rights, power and privileges of ownership, including the right to vote such stock.


