SEVERANCE AND TERMINATION OF EMPLOYMENT

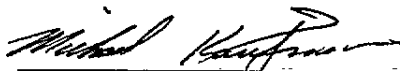

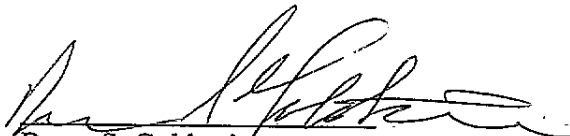
