
## ARTICLE X

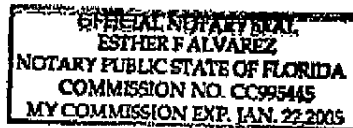


