ARTICLE IX

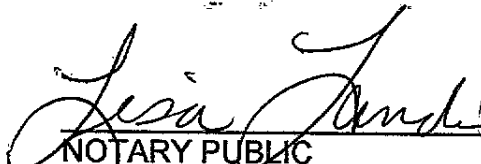

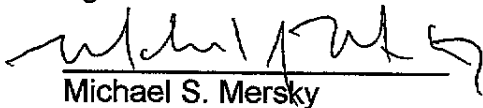
