

#### ARTICLES OF INCORPORATION OF LEGACY TRUST COMPANY



The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, and specifically, a trust company under Chapter 658, Florida Statutes, adopts the following Articles of Incorporation:

#### Article I Name

Section 1.1. Name. The name of this corporation shall be "LEGACY TRUST COMPANY."

# Article II Principal Office and Mailing Address

<u>Section 2.1</u>. <u>Principal Office and Mailing Address</u>. The principal place of business and mailing address of this corporation shall be 822 North Highway A1A, Suite 101, Ponte Vedra Beach, Florida 32082.

## Article III Capital Stock

Section 3.1. Initial Capital. The total number of shares authorized to be issued by the corporation shall be 60,000. Such shares shall be of a single class and shall have a par value of \$50.00 per share. The corporation shall begin business with at least \$1,175,000 in paid-in capital stock to be divided into 23,500 shares. The amount of surplus with which the corporation will begin business will be not less than \$825,000, all of which (capital stock and surplus) shall be paid in cash.

Article V Duration

<u>Section 5.1</u>. <u>Duration</u>. This corporation shall exist perpetually unless terminated pursuant to the Florida Financial Institutions Codes.

## Article VI Purpose and Nature of Business

Section 6.1. Purpose. This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States of America and of the State of Florida.

<u>Section 6.2.</u> Nature of Business. The general nature of the business to be transacted by this corporation shall be: That of a general trust company business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of trust corporations.

### Article VII Directors

Section 7.1. Number. This corporation shall have eight (8) directors initially. The number of directors may be increased or diminished from time to time, but shall never be less than five (5).

Section 7.3. Indemnification. The board of directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

Section 7.4. Cumulative Voting. At each election for directors every shareholder entitled to vote at such election shall have the right to vote, in person or by proxy, the number of shares owned by him for as many persons as there are directors to be elected at that time and for whose election he has a right to vote. Each shareholder may cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

## Article VIII Bylaws

Section 8.1. Bylaws. The initial bylaws of this corporation shall be adopted by the directors. Bylaws shall be adopted, altered, amended or repealed from time to time by either the shareholders or the board of directors, but the board of directors shall not alter, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the directors.

#### Article IX <u>Amendment</u>

Section 9.1. Amendment. By the shareholders only, this corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation; provided however that the Articles of Incorporation may not be amended without the prior written approval of the Florida Department of Banking and Finance.
