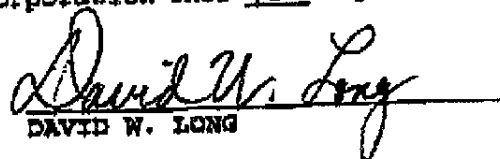
Article VIII - Incorporator

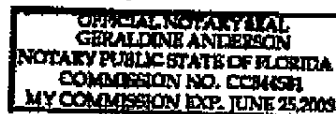
