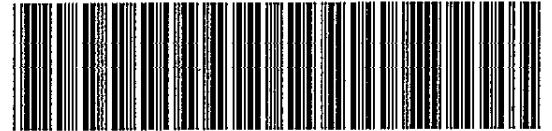

Article III Shares Amended

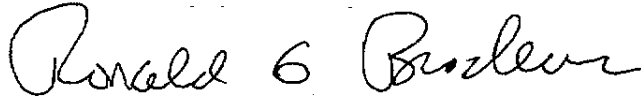
The total number of shares of stock, which the corporation shall have the authority to issue, is 500 shares at a par value of \$1.00 per share.
