ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is Z and Z Auto Center, Inc.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ARTICLE III - PURPOSE
