ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
HOMETOWN REAL ESTATE INVESTMENT TRUST CORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, this Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

- Article I. The name under which this Corporation was formed is Hometown Real Estate Investment Trust Corporation.
- Article II. The Articles of Incorporation (the "Articles") of the Corporation were filed on August 1, 2002 with the Secretary of State of the State of Florida (the "Secretary").
- Article III. The Articles were subsequently amended pursuant to Articles of Amendment that were filed on December 23, 2002 with the Secretary.
- Article IV. The Corporation hereby amends its Articles as follows:
 - a. By deleting the definition of "Transfer" in Article I, Section 1.2 in its entirety and inserting in lieu thereof the following definition:

 "Transfer" shall mean any sale, transfer, gift, assignment, devise or other disposition of Common Equity Stock or Preferred Equity Stock, including, without limitation, (i) the granting of any option or entering into any agreement for the sale, transfer or other disposition of Common Equity Stock or Preferred Equity Stock (other than to the Corporation) or (ii) the sale, transfer, assignment or other disposition of any securities or rights convertible or exchangeable for Common Equity Stock or Preferred Equity Stock (other than to the Corporation), whether voluntary or involuntary, whether of record or beneficially and whether by operation or law or otherwise.
 - b. By deleting the text of Article III, Section 3.7 in its entirety and inserting in lieu thereof the phrase "[Reserved]".

Article V. The foregoing amendment was approved by the Corporation's Board of Directors and approved by the sole holder of the Corporation's outstanding Common Stock on June 28, 2010.
