The amount of capital with which this corporation will begin business is One Hundred (\$100.00) United States Dollars.

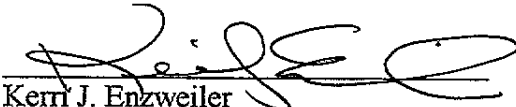
ARTICLE V. TERM OF EXISTENCE
