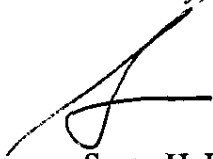
We did not know that a filing was due and had expected that our renewals would fall on incorporation anniversaries. Since we never received notification, we had no way of knowing otherwise.
