ARTICLE XI - OFFICES

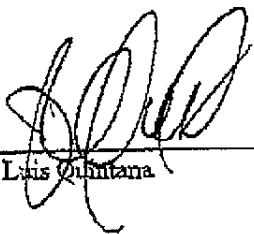
