Esteemed Sirs,

On August 2002 I created a corporation called Bishamon Investment Inc. On March 2003 I contacted Miguel Garcia an accountant referred to me by a friend. I paid him \$200 for the initial consultation, \$500.00 for one year maintenance, plus he would bill me for any additional expenses. He requested I set up a P.O. Box for the corporation so he could receive all the correspondence, I complied and obtained the P.O. Box and gave him the key as he requested. He was to file the UBR for the corporation and ensure any regulatory documents were properly handled. Last month I tried to contact him and was unable to do so, after further investigation I was told he left the country and is now living in Colombia.

The corporation was step up with plans of establishing a mortgage company. However, the department of finance requires the principal broker have one year of experience so the corporation was not used waiting to meet this requirement. The corporation has not made a single transaction, no purchases, expenses, sales or fees of any kind.

Recently I was preparing to file the documents for the mortgage broker business license and became aware that the accountant did not comply with the filing requirement and I now have fines and filing fees totaling \$750.00. When I became aware of this situation I contacted the Florida department of State Division of Corporations and discussed the situation with on of your counselors. I was told that I should explain my situation in writing and submit it with a check for the filing fees and that my situation would be re-evaluated

I have enclosed a check for \$150.00 in the hopes that the fines could be waived, so I can used this corporation for my business. If this is not possible I would like the enclosed check for \$150.00 returned and to leave this corporation in its current status, as the cost of re-activating is prohibitive.

I would very much like to comply with the requirement and can give you my personal assurance that I will personally verify all future documents are filed in a timely fashion. I would like to use this name for the new company I am about to start, I am willing to pay the \$150.00 due for the UBR, but I would be forced to start another corporation as the cost for that would only be \$80.00 rather than the \$750.00 currently due simply for using this name.
