The Corporation shall be authorized to create and issue 100 shares of Common Stock having a par value of \$1.00 per share.

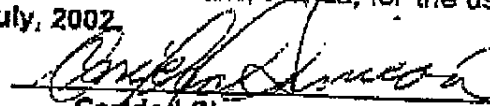

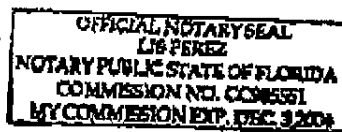
