Articles of Incorporation
of
SecThree Corporation
A Florida Corporation

The undersigned incorporator adopts the following Articles of Incorporation for purposes of forming a corporation under the Florida Business Corporation Act:

1. Name

The name of the Corporation is SecThree Corporation. The Corporation's initial principal office (and mailing address) is located at 7321 Howard Road, Bokeelia, Florida 33922.

2. Capital Structure

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time is ten million (10,000,000) shares of common stock having one-cent (\$.01) par value per share.

3. Term of Existence

The Corporation's existence shall commence on the date of filing of these Articles of Incorporation in the office of the Florida Secretary of State, and the Corporation shall have perpetual existence thereafter.
