ARTICLES OF INCORPORATION OF CITRUS HEALTH CARE, INC.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"); as follows:

I. Name

The name of the Corporation is Citrus Health Care, Inc.

II. <u>Term of Existence</u>
