# ARTICLES OF INCORPORATION OF: BRIGHT GENERAL SERVICES INC.

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.
