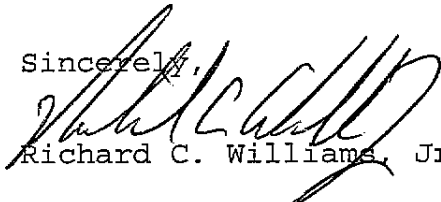

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is DANIFER PRINTING, INC.

ARTICLE II - PRINCIPAL OFFICE AND  
MAILING ADDRESS OF CORPORATION

The Corporation shall have a perpetual existence.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

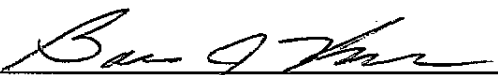

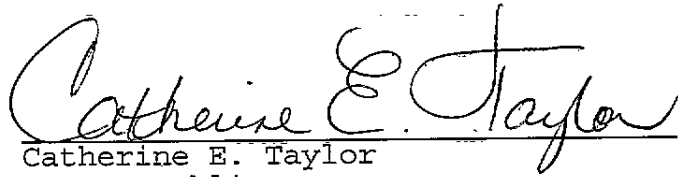

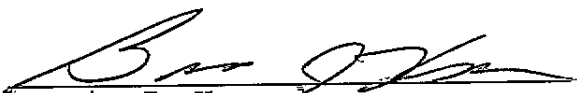
