**ARTICLES OF INCORPORATION  
OF**

**SHELBORNE PASSOVER 2003, INC.**

The undersigned, for purposes of forming a business corporation under the provisions of Florida Statutes Chapter 607, the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of this corporation shall be SHELBORNE PASSOVER 2003, INC. (hereinafter called the "Corporation").

**ARTICLE II  
PRINCIPAL ADDRESS**

The address of the principal office and the mailing address of the office of the Corporation is 9730 Stirling Road, Cooper City, Florida 33024.

**ARTICLE III  
PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV  
CAPITAL STOCK**

The corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
