ARTICLES OF INCORPORATION
OF
MI TORO #2, INC.

The undersigned, acting as the incorporators of a corporation under the Florida Business Corporation Act, adopt the following articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation ("Corporation") is Mi Toro # 2, Inc.

ARTICLE II.

The existence of the corporation shall begin on September 30, 2002

ARTICLE III.

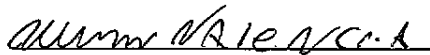
