# ARTICLES OF INCORPORATION OF TECH DATA FINANCE PARTNER, INC.



#### ARTICLE I NAME

The name of this corporation is Tech Data Finance Partner, Inc.

# ARTICLE II PRINCIPAL OFFICE

The principal office of this corporation and the mailing address of this corporation is 5350 Tech Data Drive, Clearwater, Florida 33760.

#### ARTICLE III DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of the date of filing of these Articles of Incorporation.

# ARTICLE IV PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

#### ARTICLE V CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock.

### ARTICLE IX AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the shareholders.
