ARTICLE I - NAME

The name of the corporation is L.B. Friedman, Inc. (hereinafter called the "Corporation").

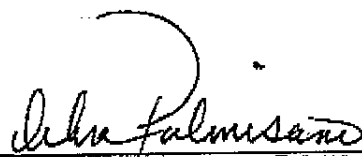
ARTICLE VI - INITIAL BOARD OF DIRECTORS

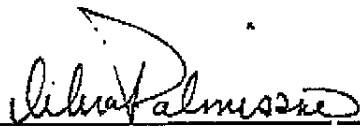
