ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation being a resturant person, competent and licensed to practice law in the State of Florida, does hereby adopt the following Articles of Incorporation for the purpose of forming a Professional Service Corporation for profit under the provisions of F.S. Chapter 621, Florida Professional Service Corporation Act, and other laws of the State of Florida.

ARTICLE 1

NAME

ARTICLE 2

PRINCIPAL PLACE OF BUSINESS

ARTICLE 3

PURPOSES AND POWERS

The general nature of the business to be transacted by the corporation is:

CAPITAL STOCK
