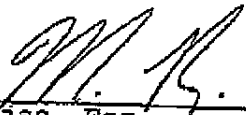
INDEMNIFICATION

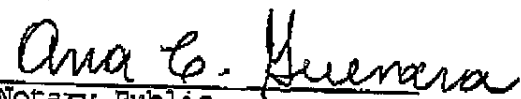
