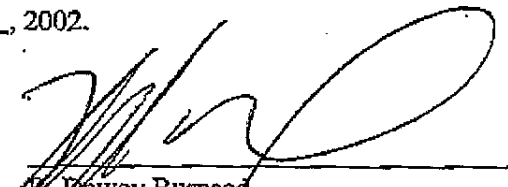
ARTICLE VI. AMENDMENT

ARTICLE VII. INDEMNIFICATION

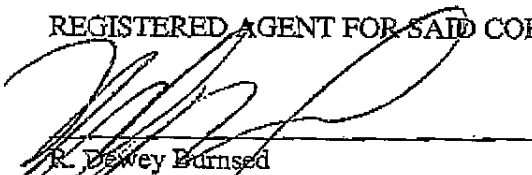
The Corporation shall indemnify its officers and directors to the fullest extent permitted by the Florida Business Corporation Act.

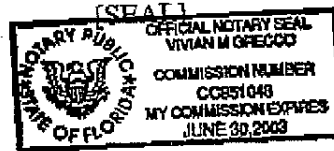
