ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is CAR INSURANCE. COM, INC.

ARTICLE II

The principal office and mailing address of the corporation is 1535 Maitland Ave., Maitland, Florida 32751.


ARTICLE V


