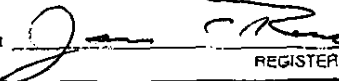

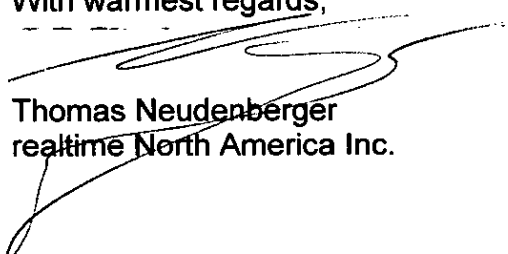
As discussed via email with Mr. Andy Dunlap I am sending you the signed Reinstatement Form for realtime North America Inc.
