It was brought to our attention by our CPA that GSC Global, Inc., corporation was dissolved. I immediately called the State and was informed that it was dissolved because we did not include our FEI number on our form UBR. Since our check for \$150. was cashed, and we did not receive a notification to the contrary, we assumed we were incorporated.

It is urgent that we reinstate GSC Global as quickly as possible as we have been and are accepting money from investors via a Private Placement Memorandum, under Rule 506 D In the Federal Statute.
