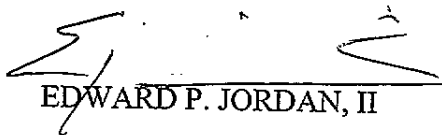

Initial Board of Directors

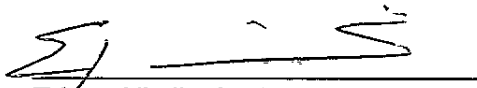
