**ARTICLES OF INCORPORATION
OF
CH AG SERVICES, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is CH AG SERVICES, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 2830 Shortwood Road, Sebring, Florida 33870

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

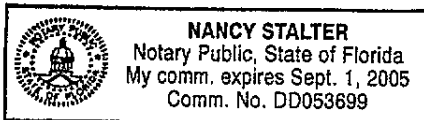

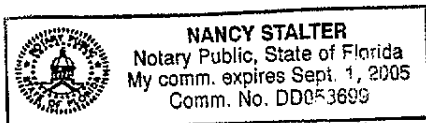
