The corporation shall have 100 shares of stock. Shelby J. Taylor to own 60 shares, and Ina L. Brewer to own 40 shares.

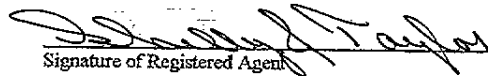

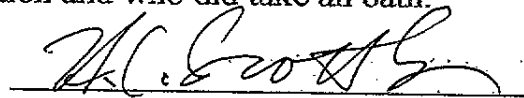
