ARTICLE NINE. AMENDMENT

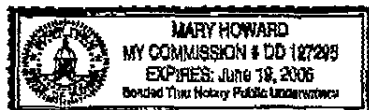

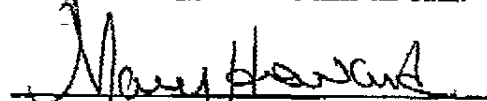

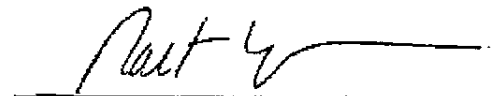
