Per the instructions offered on your 2003 UBR filing notice, I am writing to request relief from the \$400 penalty levied against my corporation for late filing.

The late notice UBR was the first notice I've received about this matter. Having only just incorporated in late 2002, I was unaware of your normal procedures for collecting this fee. My only explanation for the failure to receive the original notice is that perhaps my original filing came out around the same time as your renewal notices.

I believe this was an innocent miscommunication for which a \$400 penalty is unwarranted. I always take any matter regarding the State very seriously and have paid all my other obligations to the State in a timely matter. Fines of this size are very punitive to a very small company like mine. However, I have gladly submitted the original \$150 fee (enclosed).
