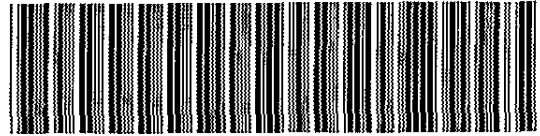

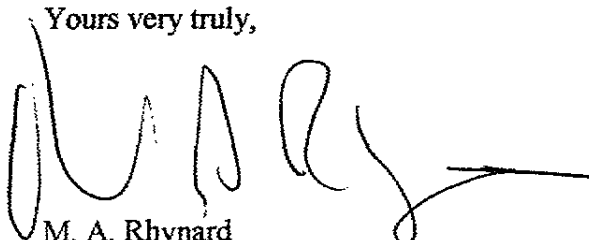

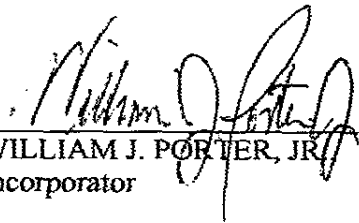
ARTICLE VIII. INDEMNIFICATION

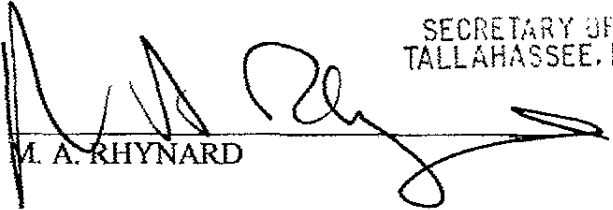

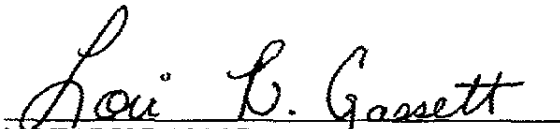
