

# ARTICLES OF INCORPORATION OF MOUNTAIN MANAGEMENT AND CONSULTING COMPANY

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

### **ARTICLE I - NAME**
