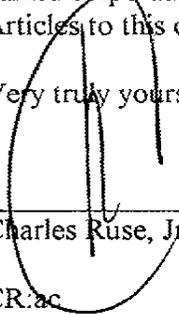

ARTICLE VIII. INCORPORATOR

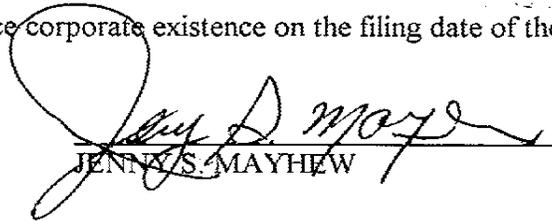

ARTICLE X. COMMENCING OF CORPORATE EXISTENCE

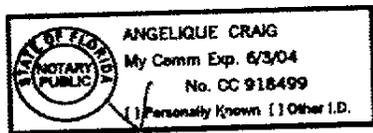

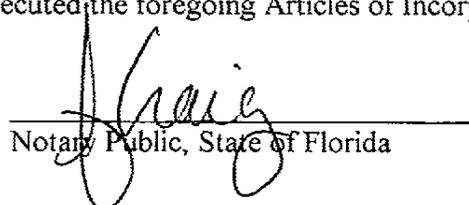
