

FIRST AMENDMENT TO ARTICLES OF INCORPORATION OF ACCESS HEALTH RISK MANAGEMENT, INC.



Pursuant to the provisions of Section 607.1006 of the *Florida Statutes*, Access Health Risk Management, Inc., a corporation organized and existing under the laws of the State of Florida, hereby adopts the following Amendment to its Articles of Incorporation:
