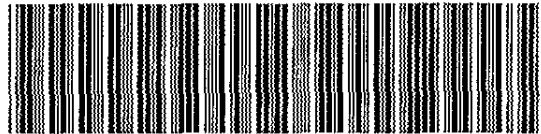

**“ARTICLE I - NAME**

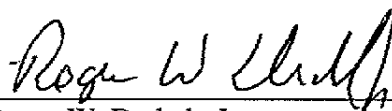
The name of this corporation is MERRITT ISLAND AIR & HEAT,
