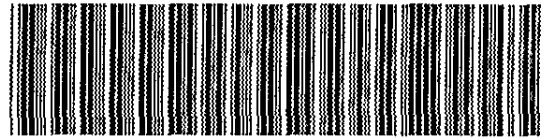

The name of this corporation is: P. Q. EQUIPMENT, INC.



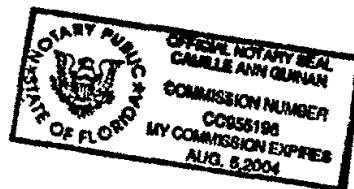
