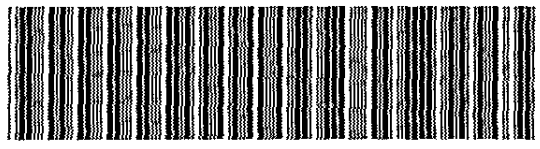



The name of the corporation is Sonny's Auto Glass, Inc.


ARTICLE X. BYLAWS
