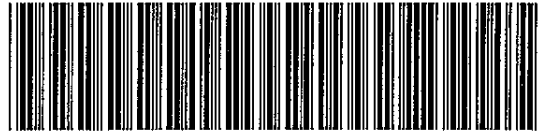

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this corporation is WASDEN SERVICES, INC.

**ARTICLE II - NATURE OF BUSINESS**

The general nature of the business to be conducted and created by this corporation is to provide for home improvements and all other related services in which a corporation is lawfully authorized to engage in the State of Florida.

**ARTICLE III - CORPORATE EXISTENCE**

This corporation shall have perpetual existence and shall commence immediately upon the filing and acceptance of this Charter by the State of Florida Department of State.


