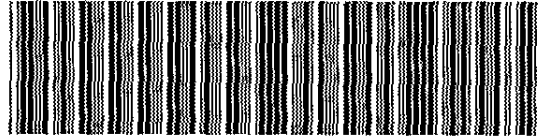

NAME**

**ARTICLE II

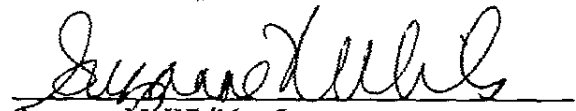

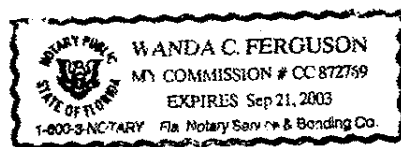

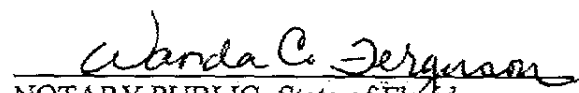
