The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Larkin Media Consultants, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on November 21, 2002 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE VI - INCORPORATOR

ARTICLE VII - BOARD OF DIRECTORS
