Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **ANDRX PHARMACEUTICALS SERVICES, INC.** (the "Corporation"), Charter #P02000124617, filed on November 21, 2002.

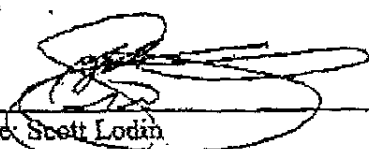
"ARTICLE I
