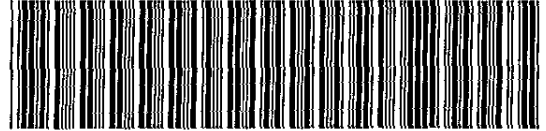

**ARTICLES OF INCORPORATION  
OF  
FINDERS-KEEPERS PLANTS II, INC.**

**ARTICLE I. NAME**

The name of this corporation is Finders-Keepers Plants II, Inc.

**ARTICLE II. DURATION**

The corporation shall have a perpetual existence.

**ARTICLE III. PRINCIPAL PLACE OF BUSINESS**
