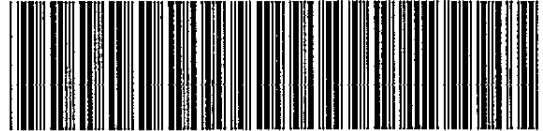

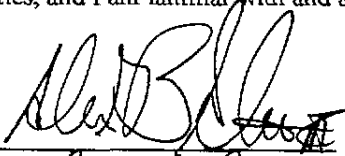

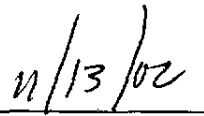
ARTICLE VIII **EFFECTIVE DATE**

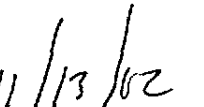
